I. PURPOSE

The purpose of this solicitation is to obtain a qualified Risk Management Consulting firm that is licensed in the Commonwealth of Virginia to provide consulting services to Newport News Public Schools (NNPS).

II. BACKGROUND

Newport News Public Schools is located within the co-terminus boundaries of the City of Newport News, Virginia. The city is 22 miles long and 4 miles wide encompassing an area of 69.2 square miles.

NNPS educates 28,654 students in 4 early childhood centers, 24 elementary schools, 7 middle schools, 1 middle-high combination school and 5 high schools. There are also programs available for at-risk students in addition to special education programs. The school division has approximately 4,500 employees of which 2,120 are teachers. A listing of NNPS and their locations may be accessed via NNPS's official web site at http://sbo.nn.k12.va.us/schools.

For the protection of the school division's students, employees, retirees, and properties, NNPS maintains various insurance policies managed by NNPS-contracted providers. Some of the major insurance coverage provided to NNPS include General Liability, Property Insurance, School Board Legal Liability, Environmental Liability, Umbrella Liability, Vehicle Self-Insurance pool with the City of Newport News and Airport Liability. The purpose of this solicitation is to obtain a qualified Risk Management Consulting firm that is licensed in the Commonwealth of Virginia to provide consulting services to NNPS, as described in this contract.

Pricing

This RFP is to request the Offeror to provide its technical methodology for accomplishing the Risk Management services requested, herein. Offeror shall not provide estimates of man-hours to perform the requested services or the cost of the services to be provided, with its proposal. However, during discussions with Offerors determined to be qualified and responsive to the RFP, NNPS may discuss nonbinding estimates of total project costs or nonbinding estimates for the price of services to be rendered. At the conclusion of discussions, NNPS will select, in the order of preference, only those Offerors whose professional qualifications and proposed methodologies for providing service is deemed most meritorious, to provide a Pricing Proposal, based on the evaluation of technical proposals, beginning with the Offeror determined to be the most qualified of all Offerors. Upon NNPS' request, the Offeror selected should provide a Price Proposal that clearly identifies any and all costs associated with performance under this contract.

However, should NNPS establish that the pricing of the most qualified Offeror is acceptable, NNPS will award to that Offeror. Notwithstanding, NNPS may determine that only one (1) Offeror is fully qualified or is clearly more qualified and suitable, in terms of professional competence, than the others under consideration and reserves the right to award a contract to only that one (1) most qualified Offeror without further discussions or deliberations with any other Offeror.

The Unit Prices offered and accepted will be Firm-Fixed for the duration of the Contract Term, and any renewal option periods exercised, and shall not be exceeded due to cost experience of the Contractor in performing the contract. Selected qualified Offerors may propose adjusted pricing for each subsequent renewal period. These prices, as well, will be Firm-Fixed for the duration of the renewal period proposed.

III. STATEMENT OF NEEDS

A. General Requirements

Contractor will provide risk management consulting services to NNPS, as it relates to NNPS property
and liability insurance. In providing these services, Contractor will work closely with the NNPS
Assistant Superintendent of Business and Support Services, as well as the Accounting Supervisor for
the school division.

B. Specific Requirements

- 1. The Contractor will be required to perform the following:
 - a. Review all insurance policies and renewals for conformity with the contract terms and conditions and for legal compliance;
 - b. Develop specific recommendations and strategies for negotiations with insurance carriers and agents;
 - c. Provide input on projected costs for future renewals, cost competitiveness, adequacy of limits, coverage terms and conditions, carrier financial strengths, and service capabilities;
 - d. Provide "hands-on" assistance in the management of renewals for individual coverage policies, as directed by NNPS;
 - e. Analyze brokers' renewal proposals and develop recommendations for the purchase or new insurance coverage;
 - f. Identify ongoing risk/loss exposure with recommendations regarding coverage extensions, where necessary and/or possible premium savings;
 - g. Review claims history and provide observational feedback and suggestions, where required regarding "loss runs" for auto and general liability coverages.
 - h. Maintain contact and discussion with the NNPS broker(s) in an effort to maximize coverage and minimize cost of the insurance product(s);
 - i. Provide assistance and input in the areas of claim reporting, handling, and settlement;
 - j. Analyze contractual agreements (insurance requirements, bonding requirements, and hold harmless clauses) and insurance policies in force to identify insurance implications and determine NNPS's ability to respond to the liabilities assumed by this agreement;
 - k. Assist in the management of NNPS's insurance program through advance premium indication/coverage changes provided by broker at least six months prior to individual policy expiration, and provide input and recommendations in the area of safety and loss control.
 - Prepare, maintain, and keep current records of all current insurance policies with abstracts, in layman's terms, of coverages afforded, exclusions, deductibles, and claim reporting requirements, including industry and current insurance coverages, which may have a significant impact on the schools' risk management program and related costs.
 - m. Develop and implement a specific planning timetable for the renewal/resolicitation of each coverage policy and prepare negotiation strategies to obtain maximum coverage for insurance renewal premium costs.
 - n. Provide interim services, regarding review and advice on specific proposals from an insurance consulting perspective. Such review by the Contractor will include, but not be limited to, the following:
 - o. Provide assistance in the RFP process by preparing requirements, meeting with NNPS staff and attending pre-solicitation conferences, offeror presentations/negotiations, analyzing bids/proposals, developing recommendations on the best proposal/bid provided, prepare detailed summation of the RFP process used to document the procurement file, and assisting NNPS staff in finalizing/refining administrative details.
 - p. Develop and deliver responses to insurance situations/questions posed by NNPS staff, as required;
 - q. Meet with designated NNPS staff, as required, to discuss/review insurance coverage and exposure aspects relative to specific types of operations.

2. Consultant(s) Qualifications

- a. Must be certified and knowledgeable in the area of Risk Management, particularly property and liability.
- b. Must be knowledgeable of Virginia state insurance regulations and requirements.
- c. Must demonstrate a pattern of continued education in the insurance industry to be able to keep NNPS abreast of changing policies, procedures, and / or regulations that may affect NNPS.
- d. Must demonstrate initiative by notifying NNPS of changes in the insurance industry without NNPS finding out from other sources and by providing NNPS with sound risk management advise and / or recommendations that will serve to protect the interest of the school division.
- e. Must be knowledgeable of carrier financial rankings and the main Virginia insurance carriers/agents in the industry.
- f. Contractor and / or Consultant must not be an insurance agent or have a financial business relationship with any insurance carrier or agent.
- g. Must be able to respond to NNPS needs in a short period of time, if necessary.

3. Performance Measures

- a. Contractor and / or Consultant's performance will be measured, based on the following, as a minimum:
 - 1. Response time in providing information and / or recommendations requested by NNPS:
 - 2. Initiative in providing information and / recommendations;
 - 3. Quality of information and / or recommendations provided;
 - 4. Professionalism of company and / or consultant;

4. Professional Standards

- a. Contractor shall perform its services with care, skill, and diligence, in accordance with the applicable professional standards currently recognized by such profession, and shall be responsible for the professional quality, technical accuracy, completeness, and coordination of all findings; recommendations; reports and information furnished under this contract.
- b. Unless otherwise agreed to by express written statement in this contract, NNPS' review and acceptance of contractor findings, recommendations, reports, and information shall in no way or manner relieve or lessen contractor's responsibility under the contract for the professional quality, technical accuracy, and completeness of such information provided.
- c. Contractor must present itself in a professional manner, to include demeanor and dress, as appropriate for the services being performed.
- d. Contractor represents and warrants to NNPS that it is experienced in and thoroughly familiar with all aspects of the Scope of Work and is properly qualified as applicable and is equipped, organized and financially able to perform the Scope of Work, herein.

5. Key Personnel

a. Contractor is required to assign Key Personnel and Key Personnel alternates to perform this contract and work closely with NNPS staff for the duration of this contract. It is expected that the Key Personnel selected and approved will be the Contractor's primary point with NNPS and will perform the duties specified by this agreement. Alternates will fill in for Key

Personnel in their absence. Key Personnel and Alternates must be approved by NNPS to perform under this contract, prior to commencement of services by the individual(s); therefore, the Contractor must submit the name and resume of any individual, not already assigned as a Key Personnel or Alternate, to the Contract Adminstrator for approval. Any weaknesses or concerns posed by NNPS, regarding candidates, must be appropriately addressed by Contractor, prior to individuals being approved. Likewise, Contractor must notify NNPS, at least two (2) weeks in advance, when an individual assigned as a Key Personnel or Alternate will no longer serve in this position for the duration of the contract. This is important for the continuity and level of quality, capability, skill, and service provided to NNPS by the Contractor.

N. Proposal Binding For One-hundred Twenty (120) Days:

Offeror agrees that its Proposal shall be binding and may not be withdrawn for a period of one-hundred (120) calendar days after the scheduled closing date of this Request For Proposals.

O. Proprietary Information/Non-Disclosure:

Offeror is advised that the Virginia Public Procurement Act (Section 2.2-4342, Code of Virginia, 1950 as amended) shall govern public inspection of all records submitted by Offeror. Specifically, if Offeror seeks to protect any proprietary data or materials, pursuant to Section 2.2-4342, Offeror shall:

- 1. Invoke the protections of this section prior to or upon submission of the data or other materials,
- 2. Provide a statement that identifies the data or other materials to be protected and that states the reasons why protection is necessary.

R. Conditions of Work:

Offeror shall inform itself fully of the conditions relating to services required herein. Failure to do so will not relieve a Successful Offeror of the obligation to furnish all goods and/or services necessary to carry out the provisions of this contract

S. Prime Contractor:

If in its performance of this contract, Successful Offeror supplies goods or services by or through another party or subcontractor, Successful Offeror agrees that:

- 1. Successful Offeror shall act as the prime contractor for the goods and services to be provided under contract and shall be the sole point of contact with regard to all obligations under this contract.
- 2. Successful Offeror represents and warrants that Successful Offeror has made third parties or subcontractors aware of the proposed use and disposition of the other party's products or services, and that such other party has agreed in writing that it has no objection and that NNPS is not liable to such third parties or subcontractors for any work performed under this contract.

Upon written demand by NNPS, Successful Offeror shall assume and defend at Successful Offeror's sole expense any and all such suits or defense of claims made against NNPS, its agents, volunteers, servants, employees or officials.

Y. Notices:

All notices, requests, demands, and elections under this contract, other than routine operational communications, shall be in writing and shall be deemed to have been duly given on the date when hand-delivered, or on the date of the confirmed facsimile transmission, or on the date received when delivered by courier that has a reliable system for tracking delivery, or six (6) NNPS business days after the date of mailing when mailed by United States mail, registered or certified mail, return receipt requested, postage prepaid. All notices shall be addressed to the following individuals:

To NNPS: NNPS Contract Administrator as designated in this RFP.

To Successful Offeror's Contract Administrator as defined in Successful Offeror's Proposal.

Either party may from time to time change the individual(s) to receive notices and/or its address for notification purposes by giving the other party written notice as provided above.

Z. Non-Performance:

- 1. Delivery Delays: NNPS reserves the right to procure goods and/or services to be provided under this contract from other sources in the event Successful Offeror fails to deliver such goods and/or service deliverables in accordance with delivery dates and time frames set forth in this contract.
- 2. Unacceptable Deliveries (Rejections): Upon notification by NNPS that goods and/or service deliverables provided by the Successful Offeror under this contract are damaged and/or not of the quality specified by NNPS, such goods and/or service deliverables will be rejected. Successful Offeror shall replace such rejected goods and/or service deliverables immediately or within a reasonable time as determined by NNPS.
- 3. Successful Offeror shall remove all rejected materials, equipment or supplies from the premises of NNPS within ten (10) days of notification. Rejected goods and/or service deliverables not removed from NNPS' premises within ten (10) days will be regarded as abandoned, shall become the property of NNPS, and NNPS shall have the right to dispose of such items.
- 4. NNPS reserves the right to authorize immediate purchase from other sources against rejections.
- 5. Liability: Successful Offeror shall be liable to NNPS for all costs incurred by NNPS as a result of Successful Offeror's failure to perform in accordance with the contract. Successful Offeror's liability shall include, but not be limited to:
 - a. Damages and other delay costs, to include costs to procure goods/services from alternate suppliers.

Unless otherwise provided, Successful Offeror shall have ten (10) days from the date such notice is mailed in which to cure the default. Upon termination, Successful Offeror shall withdraw its personnel and equipment, cease performance of any further work under the Contract, and turn over to NNPS any work in process for which payment has been made. In the event of violations of law, safety or health standards and regulations, this Contract may be immediately cancelled and terminated by NNPS and provisions herein with respect to opportunity to cure default shall not be applicable.

CC. Breach of Contract:

Successful Offeror shall be deemed in breach of this contract if the Successful Offeror:

Fails to comply with any terms of this contract;

Fails to cure such noncompliance within ten (10) calendar days from the date of the NNPS written notice or such other time frame, greater than ten (10) calendar days, specified by the NNPS Contract Administrator in the notice

Fails to submit a written response to NNPS's notification of noncompliance within ten (10) calendar days after the date of the NNPS notice.

All notices under this contract shall be submitted, either by fax or certified mail, return-receipt requested, to the respective contract administrator. Successful Offeror shall not be in breach of this contract as long as its default was due to causes beyond the reasonable control of and occurred without any fault or negligence on the part of both the Successful Offeror and its subcontractors. Such causes may include, but are not restricted to, acts of God or of the public enemy, acts of NNPS in its sovereign capacity, fires, floods, epidemics, strikes, freight embargoes, and unusually severe catastrophic weather such as hurricanes.

DD. Applicable Law:

This Contract shall be deemed to be a Virginia contract and shall be governed as to all matters whether of validity, interpretations, obligations, performance or otherwise exclusively by the laws of the Commonwealth of Virginia, and all questions arising with respect thereto shall be determined in accordance with such laws. Regardless of where actually delivered and accepted, this Contract shall be deemed to have been delivered and accepted by the parties in the Commonwealth of Virginia.

EE. Compliance With All Laws:

Successful Offeror shall comply with all federal, state and local statutes, ordinances, and regulations now in effect or hereafter adopted, in the performance of this contract. Successful Offeror represents that it possesses all necessary licenses and permits required to conduct its business and/or will acquire any additional licenses and permits necessary for performance of this contract prior to the initiation of work. If the Successful Offeror is a corporation, Successful Offeror further expressly represents that it is a corporation of good standing in the Commonwealth of Virginia and will remain in good standing throughout the term of the contract and any extensions. All City of Newport News business license, personal property, real estate and other applicable tax requirements shall be met by Successful Offeror.

FF. Venue:

Venue shall be in the Circuit Court of the City of Newport News, Virginia, and the United States District Court for the Eastern District of Virginia, Norfolk Division, compliant with applicable laws and regulations, as deemed appropriate by NNPS.

GG. Severability:

If any provision of this contract is found by any court of competent jurisdiction to be invalid or unenforceable, the invalidity of such provision shall not affect the other provisions of this contract, and all other provisions of this contract shall remain in full force and effect.

HH. Non-Appropriation of Funds:

It is understood and agreed between the parties herein that NNPS shall be bound hereunder only to the extent that the funds shall have been appropriated. In the event no funds or insufficient funds are appropriated, NNPS shall immediately notify the Successful Offeror of such occurrence and this Contract shall terminate on the last day funds are available without penalty or expense to NNPS of any kind whatsoever.

II. Tax Exemption:

NNPS is exempt from federal excise tax and from all State and local taxes. Successful Offeror shall not include such taxes in any invoices under this agreement. Upon request, NNPS will furnish the Successful Offeror with tax exemption certificates or the NNPS tax exempt number.

JJ. Vendor's Invoices:

KK. Contractual Disputes:

The decision of the NNPS Purchasing Agent shall be final and conclusive unless the contractor appeals within six (6) months of the date of the final written decision by instituting legal action as provided in the Code of Virginia. Nothing herein shall preclude a contract from requiring submission of an invoice for final payment within a certain time after completion and acceptance of the work or acceptance of the goods. Pendency of claims shall not delay payment of amounts agreed due in the final payment.

LL. Warranty/Guarantee:

Successful Offeror guarantees against defective or faulty material or workmanship for at least one (1) year or for the manufacturer's standard warranty period, whichever is greater, from date of acceptance by NNPS. To furnish adequate protection from damage for all work and to repair damages of any kind for which Successful Offeror or Successful Offeror's workmen are responsible, to the building or equipment, to Successful Offeror's own work, or to the work of others. In no event shall any interest penalty or late fee accrue when payment is delayed because of disagreement between NNPS and Successful Offeror regarding the quantity, quality, time of delivery, or other noncompliance with the contract requirements for any Product or Service or the accuracy or correctness of any invoice. Payment terms offering a "prompt payment discount" of 20 days or greater will be considered in the evaluation of Proposals. All other payment terms shall be net thirty (30) calendar days or greater. Payment terms not specified by Offeror shall be Net 45 days.

Special Educational or Promotional Discounts

Successful Offeror shall extend any special educational or promotional sale prices or discounts immediately to NNPS during the term of the contract. Such notice shall also advise the duration of the specific sale or discount price.

NN. Prompt Payment:

NNPS will promptly pay for completed, delivered goods or services accepted under this Contract by the payment date established. The required payment date will be either: (i) the date on which payment is due under the terms of this Contract for the provision of the goods or services; or (ii) if a date is not established by this Contract, not more than forty-five (45) days after goods or services are received or not more than forty-five (45) days after the invoice is rendered, whichever is later.

Within twenty (20) days after the receipt of the invoice or goods or services, NNPS shall notify the supplier of any defect or impropriety that would prevent payment by the payment date. Should NNPS fail to pay the Contractor by the pay date, finance charges may be assessed by the Contractor. Unless otherwise provided under the terms of this Contract, interest will accrue at the rate of one percent (1%) per month. This will not apply to late payment provisions in any public utility tariffs or public utility negotiated Contracts. Contractor shall include in each of its subcontracts a provision requiring each subcontractor to include or otherwise be subject to the same payment and interest requirements with respect to each lower-tier subcontractor.

In cases where payment to Contractor is made by mail, the date of postmark shall be deemed to be the date payment is made for purposes of this Contract.

Individual Contractors shall provide to NNPS their social security numbers and proprietorships, partnerships, and corporations to provide their federal employer identification numbers.

Within seven (7) days after Contractor receives payment from NNPS, Contractor shall take one or more of the following actions:

- 1. Pay all subcontractors for the proportionate share of the total payment received from NNPS attributable to the work performed by the subcontractors under this Contract;
- 2. Notify NNPS and all affected subcontractors, in writing, of Contractor's intention to withhold all or a part of each affected subcontractor's payment including the reason for nonpayment.
- 3. Pay interest to the subcontractor on all amounts owed by the Contractor that remain unpaid after (7) seven days following receipt by the Contractor of payment from NNPS for work performed by the subcontractor under that Contract, except for amounts withheld, as allowed in #2 above.

A Contractor's obligation to pay an interest charge to a subcontractor pursuant to the payment clause in this section shall not be construed to be an obligation of NNPS. A Contract modification will not be made for the purpose of providing reimbursement by NNPS for interest charges owed by Contractor. A cost reimbursement claim to NNPS shall not include any amounts for reimbursement of interest charges owed by Contractor.

OO. Payment by Electronic Funds Transfer (EFT)

If such suspension would result in a late payment under the prompt payment terms of this contract, the Contractor's request for suspension shall extend the due date for payment by the number of days of the suspension.
- (e) Liability for uncompleted or erroneous transfers.
 - (1) If an uncompleted or erroneous transfer occurs because NNPS used the Contractor's EFT information incorrectly, NNPS remains responsible for—
 - (i) Making a correct payment;
 - (ii) Paying any prompt payment penalty due; and
 - (iii) Recovering any erroneously directed funds.
 - (2) If an uncompleted or erroneous transfer occurs because the Contractor's EFT information was incorrect, or was revised within 30 days of NNPS' release of the EFT payment transaction, and—
 - (i) If the funds are no longer under the control of Accounting, NNPS is deemed to have made payment and the Contractor is responsible for recovery of any erroneously directed funds; or
 - (ii) If the funds remain under the control of Accounting, NNPS shall not make payment and the provisions of paragraph (d) shall apply.
- (f) *EFT and prompt payment*. A payment shall be deemed to have been made in a timely manner in accordance with the prompt payment terms of this contract if, in the EFT payment transaction instruction released to the Federal Reserve System, the date specified for settlement of the payment is on or before the prompt payment due date, provided the specified payment date is a valid date under the rules of the Federal Reserve System.

- (g) *EFT and assignment of claims*. If the Contractor assigns the proceeds of this contract as provided for in the assignment of claims terms of this contract, the Contractor shall require as a condition of any such assignment, that the assignee shall provide the EFT information required by paragraph (j) of this clause to Accounting, and shall be paid by EFT in accordance with the terms of this clause. In all respects, the requirements of this clause shall apply to the assignee as if it were the Contractor. EFT information that shows the ultimate recipient of the transfer to be other than the Contractor, in the absence of a proper assignment of claims acceptable to NNPS, is incorrect EFT information within the meaning of paragraph (d) of this clause.

However, NNPS does not guarantee that any particular format or method of delivery is available and retains the latitude to use the format and delivery method most convenient to NNPS. If NNPS makes payment by check in accordance with paragraph (a) of this clause, NNPS shall mail the payment information to the remittance address in the contract.

- I. The following responses to questions received and requests for clarifications are below:
 - 1. RFP Section III.B.1.b: Will the Consultant be expected to work with more than one Producer/Agent for NNPS? If yes, how many? At present, the liability and property coverage is with one company (VML). They do not use a producer/agent. It was not always that way in the past, and may not always be that way in the future. Also, we have several other small insurance policies with other brokers/agents to cover flood, airport and airplane, pollution/mold and underground storage tanks.
 - 2. RFP Section III.B.1.c: Is actuarial work needed as part of the RFP services? *No*
 - 3. RFP Section III.B.1.d: Is the Producer/Agent involved in the placement of individual policies? *VML has no producer or agent. However, in the past we did have a producer/agent for property and liability.*
 - 4. RFP Section III.B.1.g and i: Are claims self-administered or managed by a TPA? No claims for which the consultant is being hired are self-administered or managed by a TPA. (We are self-insured for vehicle claims though the City Office of Self-Insurance, our Worker Comp claims are self-insured and managed through a TPA, and health insurance claims are self-insured with Anthem as our TPA but those risks are outside the scope of this RFP.)
 - 5. RFP Section III.B.1.0: How many onsite Consultant meetings are expected each calendar year? 1 to 2, but in years in which an RFP is being prepared for liability and property insurance (usually once every 5 years), an additional meeting might be needed. Most questions and issues are handled via email or telephone.
 - 6. Who is the current RM Consultant and for how many years? *McNeary Consulting, presently merged as a division of A.J. Gallagher. McNeary has been the consultant for approximately 40 years.*
 - 7. RFP Section IV.I. pg. 11 "Experience and Past Performance", #4: This is in reference to "A&E" services. Should this be corrected to read "Risk Management Consulting" services? (Yes)

II. Remove "Pricing Section" on page 5 in its entirety and insert the following section after Experience and Past Performance section on page 11:

Price (15 pts)

- a. Submit with the proposal a Pricing Sheet that provides a cost breakdown showing the maximum guaranteed cost of the project, per year, as well as specific charges, hourly rates, retainers, and/or any other basis of billing proposed by the consultant.
- b. Offeror's prices will be subject to negotiations.
- c. After negotiations and award of this contract, Successful Offeror's pricing for the services provided under this contract shall be a firm fixed-price during the term of the contract and any extensions. The Unit Prices offered and accepted will be Firm-Fixed for the duration of the Contract Term, and any renewal option periods exercised, and shall not be exceeded due to cost experience of the Contractor in performing the contract. Selected qualified Offerors may propose adjusted pricing for each subsequent renewal period. These prices, as well, will be Firm-Fixed for the duration of the renewal period proposed.
- III. Evaluation point scoring is as follows:

Services to be Provided: 35 pts
Capabilities and Skills: 30 pts
Experience and Past Performance: 20 pts
Price: 15 pts

IV. Remove "I. Evaluation of Proposals" section on page 9 in its entirety and replace with the following:

I. Evaluation of Proposals:

- 1. After the proposal opening, NNPS will select for further consideration two or more Offerors deemed to be fully qualified and best suited among those submitting proposals based on Offerors' responses to the information requested in this RFP.
- 2. The following criteria will be used in the evaluation process:
- 1) Services to be provided (35%) by the Offeror, including those services specified in the Scope of Work section of this RFP;
- 2) Offeror's capability and skills (30%) to perform the services required, including qualifications of staff, financial position, previous experience in benefit consulting, management of employee benefits, risk management experience, and design/evaluation of insurance plans.;

- 3) Offeror's experience and past performance (20%) in providing the services requested, including organization size and time in business and
- 4) Price (15%).

Exceptions/Alternatives will also be considered.

- 3. Based on the initial evaluation, NNPS may request the selected Offerors to make oral presentations. Thereafter, NNPS will conduct negotiations with each of the selected short-listed Offerors. Individuals representing the Offeror during negotiations shall have the authority to negotiate and contractually bind the company to a contract.
- 4. After negotiations are completed, NNPS will select the Offeror who, in NNPS's opinion, has made the best proposal and shall award the contract to that Offeror (referred to in this RFP as the Successful Offeror). Should NNPS determine in writing and in its sole discretion that only one Offeror is fully qualified, or that one Offeror is clearly more highly qualified than the others under consideration, a contract may be negotiated and awarded to that Offeror.
- 5. NNPS is not required to furnish a statement of the reason(s) why a proposal was not deemed to be the most advantageous.

All other provisions of the RFP shall remain unchanged. This provision shall become part of the RFP package, and Offeror acknowledges receipt of the Addendum by signing in the space provided below and returning it with the Proposal.
